

Exhibitor Program Rules: Updated 2024

- **1.** Every horse must be Nominated to Cash For Color before it is eligible to be shown and a copy of the COLOR breed registration papers must be submitted with nomination.
- **2.** Every horse entered in CASH FOR COLOR, LLC classes must have a stall at the Color Breed Congress.
- **3.** Exhibitors must show in corresponding class in The Color Breed Congress schedule to be eligible for CA\$H FOR COLOR, LLC participation.
- **4.** All exhibitors must be in good standing and have current membership with their respective National Color Breed Association and NSBA. A competing Color horse is one who is registered REGULAR registry in one of the listed associations (APHA, ApHC,PtHA, ABRA/IBHA, PBHA, ARHA)
- **5.** All horses competing in the NSBA portion of the program must have their NSBA registration. Owner and Exhibitor must be members in good standing with the NSBA to be eligible for trophy and added money payout.
- **6.** Every horse must pay the NSBA entry fee for each class entered to be eligible for the trophy and added money payout.
- 7. Three or more entries are required in any class to qualify for the added money payout.
- **8.** Non-Pro is defined as a Youth/Junior (youth/junior must be 18 years of age or younger) or an Amateur with a current valid Amateur card and must be the owner or direct relative of the owner of the horse being shown. Additionally, he/she has NOT within the past three years received Remuneration in any form of compensation directly or indirectly for a service related to an equine for professional purposes.
- **9.** Leased horses must have a current lease filed with its main Breed Association as well as the NSBA and Pinto Horse Association before being shown in the Cash For Color Program.
- Make checks payable to CASH FOR COLOR, LLC. Payment is also accepted via Credit Card with a 4% convenience fee and/or PayPal, mjpi@cashforcolor.com, Friends and Family.

- **11.** Cuts or splits for a class will be implimented when the number of entries exceeds the arena's working capacity, subject to show management's discretion.
- **12.** In all Cash For Color Two Year Old and Three Year Old Western classes entrants must use a snaffle or bosal. All bosals must use a mecate rein, which may or may not include the tie-rein
- **13.** In all Cash For Color Two Year Old Hunter Under Saddle classes an English snaffle bit must be used. In all Cash For Color Three Year Old or older Hunter Under Saddle classes an English snaffle (no shank), Kimberwick, Pelham, Mylars and/or full bridle (with two reins), all with cavesson nosebands and plain leather browbands must be used.

- **14.** There will be NO crossover from the Western Pleasure Division to the Ranch Pleasure Division.
- **15.** An exhibitor must carry a Walk Trot Card to enter the Walk Trot classes. NO crossover will be permitted to Lope classes.
- **16.** All entry and nomination fees are prepaid. In the event of death before a horse has been exhibited in the Cash For Color Program the Nomination fee can be refunded upon request with a Veterinarian letter. In the event of a horse's death during the show, HALF of the entry fee can be refunded upon request with a Veterinarian letter.
- A W-9 Form is required with each exhibitor's entry. NO payback will be processed without a W-9. <u>https://www.irs.gov/pub/irs-pdf/fw9.pdf</u>
- **18.** All exhibitors agree that their photos can be used without notification for promotional purposes on Social Media outlets, Websites and printed material.
- 19. NSBA drugging rules, drug testing rules and protocol will be strictly followed. Drug testing will be conducted by an authorized representative of NSBA at the NSBA' s discretion. A signed NSBA SHOW MEDICATION DECLARATION FORM must be completed when administering all medications. If a horse fails a drug test, all money or prizes must be returned immediately to Cash For Color, LLC.
- **20.** Added classes or Late entries must be made at the Cash For Color booth by 4:00pm the day prior to the class being entered.
- **21.** Horses disqualified for any reason from a CASH FOR COLOR, LLC class will not be awarded any refund or payout. If a horse is exhibited and DQ'd exhibitor will still receive a prize bag.
- **22.** All exhibitors must allow their equipment and/or horse to be examined by the NSBA Steward, and/or judge.
- **23.** Any rules or procedures herewith can be changed, added to, or denied at the discretion of the CASH FOR COLOR, LLC Management. The CASH FOR COLOR, LLC Management has the final word in interpreting or supplementing the rules and conditions.
